

Resort Village of Coteau Beach
Bylaw No. 1 2021
A Bylaw to Stop the Annexation of Coteau Developments Inc.

The Council of the Resort Village of Coteau Beach in the Province of Saskatchewan enacts as follows:

Short Title

1. This bylaw shall be known as the "Bylaw to Stop the Annexation of Coteau Developments Inc."

Interpretation

1.1 In this bylaw:

- a. 'Council' shall mean the Council of the Resort Village of Coteau Beach;
- b. 'CDI' shall mean the subdivision known as Coteau Developments Inc., located in the RM of Coteau No. 255. A map showing the properties within the subdivision is attached and forms part of this bylaw as Schedule I.

2. Council received a petition on June 15, 2020 which was found to be sufficient on June 29, 2020 by Administrator Steven Piermantier. The question on the petition was as follows: Do you want a referendum vote by the Resort Village of Coteau Beach voters on the matter of annexation of Coteau Place as represented by Coteau Developments Inc. with the Resort Village of Coteau Beach?

3. A vote on the above question was held on January 16, 2021 with the following question put to the electors of the Resort Village:

Do you want the Council of the Resort Village of Coteau Beach to stop the annexation process with Coteau Place as represented by Coteau Developments Inc. from the RM of Coteau No. 255?

4. The results of the vote held in Section 3 were as follows:

For / Affirmative: 90;

Against / Negative: 52;

Number of ballots rejected: 0.

5. In accordance with the results of the January 16, 2021 vote, Council will not pursue the annexation of CDI.

6. Council will consider the repeal or amendment of this bylaw only if one or more of the conditions described below exist, in accordance with Section 140 of *The Municipalities Act*:

alip

- a. three years have passed from the date that this bylaw was passed and public notice is given of the proposed amendment or repeal; or
- b. amendment or repeal of this bylaw is necessary to avert an imminent danger to the health or safety of the residents of the Resort Village of Coteau Beach.

7. Council will not accept a petition on the same or a similar subject as that mentioned in Sections 2 or 3 of this bylaw within three (3) years of the date of the annexation vote – January 16, 2021 - in accordance with Section 136(6) of *The Municipalities Act*. The earliest Council will accept a petition as described in Sections 2 or 3 of this bylaw is January 17, 2024.

8. The public notice described in Section 6.b. shall be least 21 days before the proposed amendment or repeal is first considered by Council.

9. This bylaw may be amended if the amendment does not affect the substance of the bylaw.

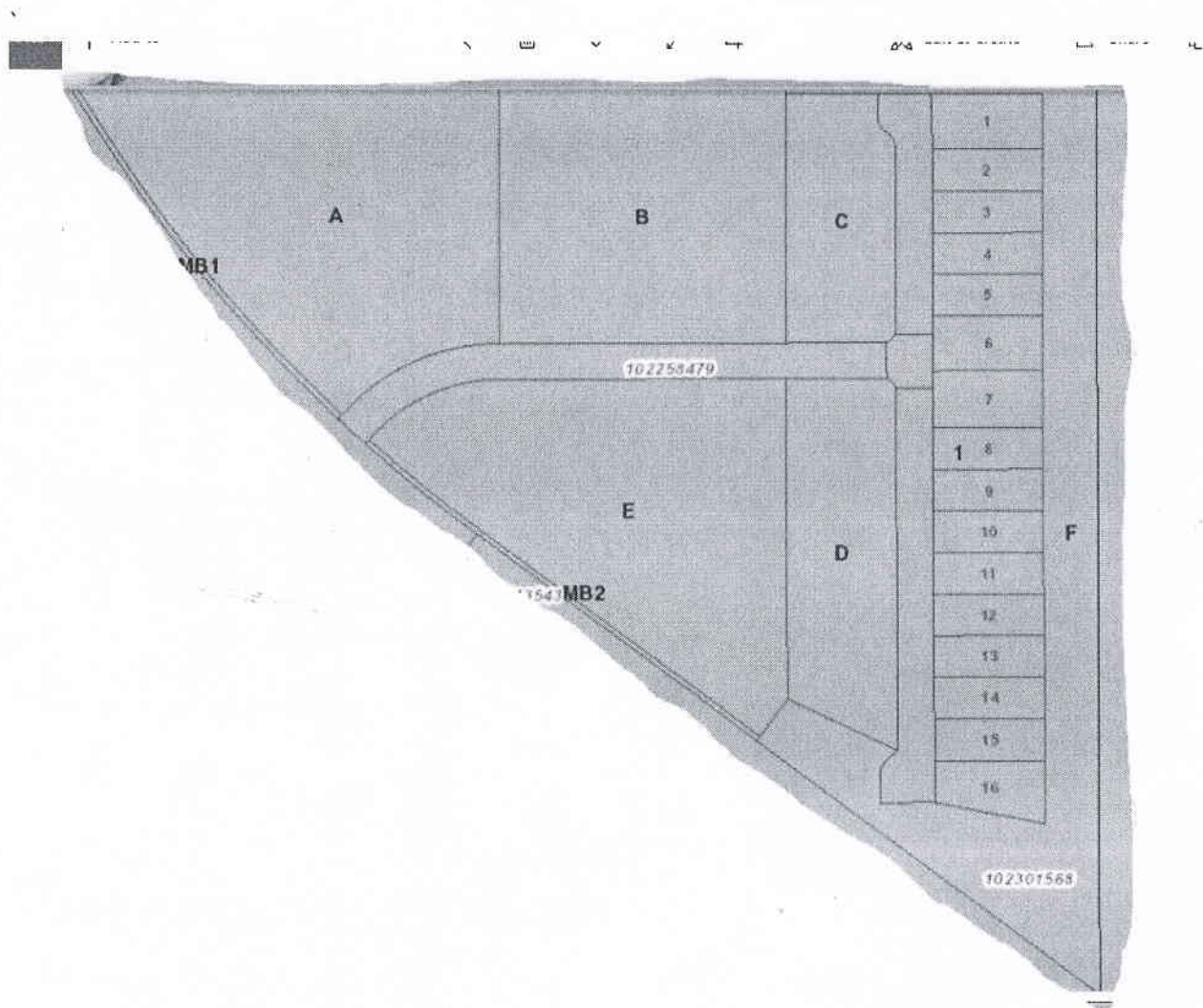
